



Summary

The thirty-eighth session of the Statistical Commission marked the sixtieth anniversary of the Commission. In his opening remarks, the newly elected chairperson underlined the strong professional leadership that had been provided by the Commission in building the global statistical system in the past 60 years. In their statements, the members of the Commission unanimously shared that sentiment and highlighted as key achievements of the Commission the creation of a body of global statistical standards and guidelines and a culture of close international cooperation in statistics based on shared professional ethics among the heads of national statistical offices. The members cited concrete examples of how the work of the Commission had assisted countries in building national statistical systems, especially in the context of decolonization and the transition to market economies and in post-conflict situations. The important role of the Commission as a forum in which to share practical experiences in the development of national statistics was repeatedly stressed. The members also acknowledged the support provided by the United Nations Statistics Division and expressed their gratitude for the organization by the Division of a number of special commemorative events. Strengthening the autonomy and independence of official statistics at the national level and maintaining the technical focus of the work of the Commission at the global level were underscored as the key conditions for the successes of the past and in the future.

As a primary concern of the Commission was to make nationally produced statistical data comparable internationally through the development of conceptual and methodological standards, the Commission had continued its technical work in that area by adopting two statistical norms: (a) the Principles and Recommendations for Population and Housing Censuses, Revision 2; and (b) the System of Environmental-Economic Accounting for Water. It had also continued its technical discussions in the areas of national accounts, leading up to revised future standards in those fields. The Commission had also reviewed current activities in the fields of education statistics, agricultural statistics, disability measurement, information and technology international communication statistics. economic and social classifications, the management of national statistical systems and the International Comparison Programme, and it had provided guidance for future work in those areas.

The Commission recognized the need for continuous improvement of the statistics required to track progress towards the Millennium Development Goals. The heads of national statistical offices again stressed the importance of statistical capacity-building, requesting that all stakeholders, particularly international organizations, give due consideration to Economic and Social Council resolution 2006/6 on strengthening statistical capacity. The Commission recognized that donor coordination was of importance and should be further enhanced.

B. Decisions brought to the attention of the Council

2. The following decisions adopted by the Commission are brought to the attention of the Council:

38/101 Programme review: education statistics

The Statistical Commission:

(a) Welcomed with appreciation the report of Statistics Canada on education statistics,¹ took note of the recommendations contained therein and requested Statistics Canada to provide the full report to all members and observers of the Commission;

(b) Agreed to set up a task force on education statistics comprising interested countries and agencies and asked the UNESCO Institute for Statistics to be the convener of the task force;

(c) Requested the United Nations Statistics Division, in collaboration with the UNESCO Institute for Statistics, interested countries and agencies, to prepare the draft terms of reference of the task force and to submit them to the Bureau of the Commission for approval. The terms of reference could include the following tasks:

(i) Further reviewing and analysing the accumulated experience of countries and various agencies;

(ii) Developing a conceptual framework for education statistics that would build on what currently exists and that would suit the needs of developed and developing countries;

(iii) Reviewing the coordination mechanism among relevant agencies and proposing new arrangements, if necessary, to avoid duplication of tasks and to reduce the country response burden;

(d) Welcomed the proposal by the UNESCO Institute for Statistics to organize a working session of interested countries and organizations on education statistics as soon as possible in 2007 in order to provide input to the workplan of the task force;

(e) Requested the task force to develop its workplan and begin its implementation, and to submit a progress report to the Commission in 2008.

38/102

Population and housing censuses

The Statistical Commission:

(a) Welcomed and adopted the second revision of the *Principles and Recommendations for Population and Housing Censuses*² and encouraged countries to begin its implementation;

(b) Requested that the text of the revised guidelines be released in all official United Nations languages as soon as possible;

(c) Requested the United Nations Statistics Division and other international agencies to increase their technical assistance to national statistical offices in order

to strengthen national capacity for the implementation of the 2010 World Programme on Population and Housing Censuses;

(d) Recognized with appreciation the support being given to countries to implement the 2010 World Programme on Population and Housing Censuses by the United Nations Population Fund, the World Health Organization and the Interstate Statistical Committee of the Commonwealth of Independent States.

38/103 Disability measurement

The Statistical Commission:

(a) Welcomed the report of the Washington Group on Disability Statistics³ and noted its appreciation of the work carried out by the Group;

(b) Acknowledged the progress made towards the elaboration of a set of census questions on disability based on the World Health Organization International Classification of Functioning, Disability and Health;

(c) Endorsed the workplan for 2007, as set out in paragraphs 11 and 12 of the report, with particular reference to:

(i) Finalizing the analysis of the test data and short set of questions for use in the population census;

(ii) Addressing the issue of upper body functioning in the set of questions;

(iii) Providing a fully elaborated set of questions to be used in sample surveys;

(d) Encouraged the Washington Group, as part of its follow-up activities, to assist countries in their implementation of recommended questions for the measurement of disability through censuses and surveys;

(e) Requested the Washington Group to collaborate with the World Health Organization in the context of the application of the International Classification of Functioning, Disability and Health and with the Budapest Initiative on the measurement of health status in order to enhance coordination and avoid duplication of resources.

38/104

Information and communication technology statistics

The Statistical Commission:

(a) Endorsed the core list of information and communication technology indicators as contained in annex II of the report of the Partnership on Measuring Information and Communication Technologies for Development;⁴

(b) Congratulated the Partnership on its work and recognized the leadership of the United Nations Conference on Trade and Development in initiating the Partnership, which had become an example of successful cooperation among international organizations;

(c) Encouraged countries to use the core list of indicators in their data collection programmes;

(d) Recognized that information and communication technology was a rapidly evolving area, and encouraged the Partnership to continue work to improve and update the list of indicators, especially with regard to measuring the use of information and communication technology in education and in government, the contribution of such technology to economic growth and social development, and the barriers to the use of the technology;

(e) Encouraged the Partnership to assist countries in their capacity-building efforts for the collection of data for the information and communication technology indicators.

38/105 Agricultural statistics

The Statistical Commission:

(a) Took note with appreciation of the report on agricultural statistics⁵ and the recommendations presented by the Food and Agriculture Organization of the United Nations;

(b) Commended the work of the Food and Agriculture Organization of the United Nations on the FAOSTAT, CountrySTAT and RegionSTAT databases and encouraged the Organization to further improve those databases, especially with respect to metadata, the transparency of data sources and coordination with regional entities that already collect data in that field;

(c) Endorsed the efforts to explore ways in which the various national census activities, including agricultural and population censuses, could be coordinated to create greater synergy, efficiency and value added between those large statistical exercises;

(d) Supported the view that agricultural statistics needed to be further integrated with other statistical areas, in particular with economic and environment statistics, focusing thereby on outcomes;

(e) Welcomed the efforts of the Food and Agriculture Organization of the United Nations to keep national statistical offices informed and involved in the compilation of agricultural statistics;

(f) Expressed appreciation for the technical assistance on agricultural statistics provided by the Food and Agriculture Organization of the United Nations to countries and encouraged the Organization to continue to provide such assistance;

(g) Endorsed the creation of a city group on statistics on rural development and agriculture household income and welcomed the proposal of United Kingdom of Great Britain and Northern Ireland to host the first meeting in Wye;

(h) Agreed with the Food and Agriculture Organization of the United Nations assessment of the consultation mechanism on agricultural statistics and the replacement of the Intersecretariat Working Group on Agricultural Statistics by the international advisory group on agricultural statistics of the Food and Agriculture Organization of the United Nations.

38/106 National accounts

The Statistical Commission:

(a) Commended the Intersecretariat Working Group on National Accounts for completing in a transparent manner the recommendations on the 44 issues identified for the update of the *System of National Accounts, 1993* and for involving the global statistical community in accordance with the agreed timetable;

(b) Adopted the package of recommendations on the update of the *System of National Accounts, 1993* presented by the Intersecretariat Working Group to the Commission, as set out in the background document entitled "The full set of consolidated recommendations", with additional considerations on five issues as set out in sections III.C and III.D of the report of the Intersecretariat Working Group on National Accounts⁶ and in the background document containing its supplement;

(c) Emphasized the need to establish guidelines on when to recognize pension entitlements in the core set of accounts, to undertake additional research on the estimation of research and development as capital formation, to provide guidelines taking into consideration the impact of the treatment of goods for processing on input-output analysis and the recording of international trade and to elaborate on the guidelines on the integrated measurement of the informal sector within the national accounts;

(d) Reiterated its request to the Intersecretariat Working Group to submit to the Commission in 2008 a strategy for the implementation of the *System of National Accounts*, based on regional consultations in 2007, reflecting user perspectives and taking into account the different levels of implementation across countries;

(e) Took note that the current update had retained the framework of the *System of National Accounts, 1993* and therefore encouraged countries to continue with the implementation of the *System of National Accounts, 1993*;

(f) Requested the Intersecretariat Working Group to act on the concerns raised by the Commission with regard to supporting countries in establishing a basic data collection strategy for the implementation of the *System of National Accounts*, the integration of the informal sector in the national accounts and the need for capacity-building to implement the strategy and recommendations;

(g) Underlined the importance of preparing handbooks and manuals with implementation guidance and to enhance capacity-building through training and technical assistance;

(h) Took note of the proposal by the Intersecretariat Working Group to present to the Commission the draft of the update of the *System of National Accounts, 1993* in two volumes: volume one, in 2008, comprising a full set of chapters representing the framework in terms of accounting conventions, the accounts, and the integration of the accounts and incorporating the adopted recommendations on the 44 issues; and volume two, in 2009, comprising interpretations of the accounts and extensions such as satellite accounts;

(i) Requested the Intersecretariat Working Group to continue to report to the Commission on the progress in the implementation of the *System of National Accounts* by countries, focusing on scope, coverage and quality;

(j) Supported the formation of a high-level group to examine the long-term implications of the *System of National Accounts* and possible future changes, taking into consideration rapid changes in the global economy; the need to balance users' needs, theory and the ability to collect primary data; the choice between imputed versus observable transactions; and the role of satellite accounts vis-à-vis the core accounts; and requested the Intersecretariat Working Group to establish the high-level group and to ensure broad country representation in it.

38/107 Environmental accounting

The Statistical Commission:

(a) Commended the work of the Committee of Experts on Environmental-Economic Accounting⁷ and stressed the importance of the work of the Committee in elevating the level of the *Handbook of National Accounting: Integrated Environmental-Economic Accounting 2003* to that of an international statistical standard based on an agreed issues list and taking into consideration consistency with the revision of the *System of National Accounts, 1993* and other revised macroeconomic standards;

(b) Adopted part 1 of the System of Environmental and Economic Accounting for Water as an interim international statistical standard, recognizing significant demand from the users' community, and encouraged its implementation in countries;

(c) Requested that the System of Environmental and Economic Accounting for Water be re-evaluated by the Commission at the time the revised *Handbook of National Accounting: Integrated Environmental-Economic Accounting* is submitted to the Commission for adoption as an international statistical standard;

(d) Requested the United Nations Statistics Division to develop and submit to the next Statistical Commission an implementation strategy for the System of Environmental and Economic Accounting for Water, taking into account the fact that

countries were at different stages of development of environment statistics and environmental-economic accounting;

(e) Called upon countries and international agencies to allocate sufficient resources to the revision of the *Handbook of National Accounting: Integrated Environmental-Economic Accounting 2003* in their work programme in view of the urgent need for that revision;

(f) Requested the Committee of Experts to develop and submit to the next Statistical Commission a project management framework for the revision of the *Handbook of National Accounting: Integrated Environmental-Economic Accounting*, 2003 and to report on progress;

(g) Called upon the Committee of Experts to continue, within its mandate, to coordinate with the city groups and other expert groups working in environmental-economic accounting and related statistics;

(h) Encouraged the United Nations Statistics Division and the Committee of Experts to continue to organize user-producer conferences in order to build on the success of the User-Producer Conference on Water Accounting for Integrated Water Resource Management;

(i) Took note of the results of phase I of the Global Assessment of Environment Statistics and Environmental-Economic Accounting, confirmed its application for assessing the current and planned scope of implementation of the *Handbook of National Accounting: Integrated Environmental-Economic Accounting* in countries and welcomed phase II of the Global Assessment in 2007, with a focus on the specific subject areas identified by countries in phase I.

38/108 International economic and social classifications

The Statistical Commission:

(a) Agreed with the implementation process for the International Standard Industrial Classification of All Economic Activities and the Central Product Classification, as outlined in the report of the Secretary-General,⁸ especially with regard to the development of user guides and correspondence tables and the provision of technical assistance to countries;

(b) Requested that the timetable presented in paragraph 25 of the report be reviewed, recognizing at the same time the need for flexibility and the wish to advance the suggested implementation target dates;

(c) Requested that correspondence tables between the revised classifications and previous versions be made available as soon as possible;

(d) Encouraged countries to share experiences in the implementation of the revised classifications, noted the interest expressed by India and Japan in assisting other countries in the implementation process of the revised classifications and encouraged other countries to offer their assistance;

(e) Agreed with the draft structure of the International Standard Classification of Occupations presented in the background document as a suitable standard for internationally comparable statistics;

(f) Noted that draft definitions of the proposed categories of the International Standard Classification of Occupations as needed for the tripartite meeting when it considers the structure of the Classification late in 2007, and language versions of the Classification were important prerequisites for its successful implementation;

(g) Took note of the forthcoming steps to be taken in the formal process to approve the International Standard Classification of Occupations;

(h) Requested the International Labour Office to report back to the Commission in 2008.

38/109

Management issues in national statistical offices: access to microdata

The Statistical Commission:

(a) Welcomed with appreciation the report prepared by the Australian Bureau of Statistics⁹ laying out principles and guidelines for managing statistical confidentiality and microdata access;

(b) Approved the proposed set of principles and guidelines, underlining the extreme importance of ensuring confidentiality and maintaining public trust;

(c) Recognized the need of national statistical offices to find a proper balance between the importance of access to microdata for statistical analysis and the protection of confidentiality, and also recognized the need for specific training in that respect;

(d) Recognized that success in managing statistical confidentiality and microdata access depended on the size of a country's population, the maturity of a country's statistical system, and the existence of legal arrangements that protected privacy and provided rules governing access to data and whether that was culturally acceptable, so as not to affect negatively cooperation in statistical data collection;

(e) Noting that a number of international agencies and other institutions were serving as data depositories:

(i) Emphasized that countries retained ownership of their submitted data and control over its access;

(ii) Underscored the need for greater transparency in policies governing the release of data by the depositories;

(iii) Encouraged adequate consultation between countries and the depositories on granting access to data.

(f) Requested the United Nations Statistics Division to collect and to make available best practices relating to managing statistical confidentiality and microdata access and to assist with capacity-building on microdata access practices, as well as with strengthening national statistical offices institutionally to conduct some research in-house and, where applicable, in collaboration with the research community.

38/110 Development indicators

The Statistical Commission:

(a) Welcomed the work carried out by the Inter-Agency and Expert Group on Millennium Development Goal Indicators,¹⁰ as well as the improvements made with respect to the Millennium Development Goals indicators website and database, including their presentation and structure;

(b) Recognized the need for continuous improvement in the statistics needed to track progress towards the Millennium Development Goals;

(c) Stressed the need to regionalize some of the global activities so that countries could share their experiences at the regional level;

(d) Requested the United Nations Statistics Division, regional commissions and other international agencies to assist countries in two main areas:

(i) Enabling them to have the necessary data and methodologies to monitor achievements at the country level towards the Millennium Development Goals;

(ii) Facilitating the development of a coordinated reporting mechanism in order to provide a consolidated data set to users and international agencies;

(e) Reiterated the concern on the need to improve communication between countries and international agencies, as well as within the national statistical systems, on the compilation of indicators;

(f) Encouraged international organizations to use national statistical data more extensively and to produce estimates only when national data were not available and requested international agencies to ensure that consultation with countries had taken place prior to dissemination of international Millennium Development Goals figures, especially with respect to imputations of missing data.

38/111 Statistical capacity-building

The Statistical Commission:

(a) Welcomed the report of the Secretary-General on strengthening national capacity in statistics¹¹ and agreed with its recommendations on future steps;

(b) Recognized that donor coordination was of importance and that the coordination should be further enhanced by making full use of mechanisms already in place to coordinate international assistance initiatives;

(c) Requested the Committee for the Coordination of Statistical Activities and the Partnership in Statistics for Development in the Twenty-first Century to examine whether a new mechanism was required to further enhance coordination in order to gain maximum effectiveness and advocacy for government funding of statistics;

(d) Stressed that capacity-building activities of international agencies at the country level should be demand-driven rather than supply-driven, and that any assistance provided to countries should have a long-term perspective on building their capacity to produce necessary data in a sustainable way rather than an ad-hoc approach limited to finding short-term solutions;

(e) Requested that all stakeholders, particularly international organizations, give due consideration to Economic and Social Council resolution 2006/6 on strengthening statistical capacity;

(f) Re-emphasized the urgency to assist countries in establishing a mechanism for coordination within the national statistical system and requested the United Nations Statistics Division to propose guidelines for improved coordination;

(g) Welcomed the broad recognition by the donor community at the Third Round Table on Managing for Development Results of the urgent need to increase financing for the development of statistics;

(h) Welcomed the ongoing initiatives of the United Nations Statistics Division, regional commissions and other international agencies to achieve greater coordination in operational activities at the country level.

International Comparison Programme

The Statistical Commission:

(a) Expressed its appreciation of the considerable progress in the current round of the International Comparison Programme;¹² commended the Global Office of the International Comparison Programme at the World Bank, the regional coordinators and other institutions involved for their joint efforts as they approached the completion of the 2005 round of global purchasing power parity comparisons based on improved methodology and data quality;

(b) Welcomed the high-level cooperation of 144 countries and the respective regional coordinators participating in the project;

(c) Took note of the publication dates of September 2007 for price-level data for household consumption and December 2007 for the full gross domestic product results;

(d) Urged the World Bank to derive maximum benefit from the global results by actively engaging users to increase their understanding of the results, thereby

raising their awareness of the richness of data produced by the project and promoting the variety of analytical and policy uses of International Comparison Programme data;

(e) Took note of the concern that the forthcoming round of the International Comparison Programme should proceed reasonably quickly so that the investment in the current round would not be lost and so that the International Comparison Programme would be aligned with the consumer price index data collection to the maximum extent possible;

(f) Agreed to the creation of a friends of the chair group to evaluate the current International Comparison Programme with respect to its scope and activities and to make a proposal on the desirability of a new round of the Programme, taking into consideration the lessons learned from the evaluation, and to report back to the Commission in 2008;

(g) Encouraged the World Bank and its international partners actively to seek funding in order to be able to maintain a core capacity as developed during the current round of the International Comparison Programme.

Chapter V Provisional agenda and dates for the thirty-ninth session of the Commission

4. At the same meeting, the Commission decided to recommend to the Economic and Social Council that its thirty-ninth session should be held from 26 to 29 February 2008 (see chap. I, sect. A).

5. Also at its 6th meeting, on 2 March 2007, the Commission approved its draft multi-year programme of work for 2007-2010 as orally amended (see chap. I, sect. B, decision 38/114).

Chapter VI Report of the Commission on its thirty-eighth session

1. The Commission considered item 7 of its agenda at its 6th meeting on 2 March 2007.

2. At the 6th meeting, on 2 March, the Rapporteur introduced the draft report of the Commission on its thirty-eighth session (E/CN.3/2007/L.3), together with an informal text of decisions.

3. At the same meeting, statements were made by the representatives of Canada, the United Kingdom, Cuba, Germany, the United States and Finland and by the observers for Suriname, Morocco, Iraq, Australia, New Zealand, the Niger, Brazil and India.

4. Chapter VII Organization of the session

2. At the 1st meeting, on 27 February, the Chairman made an opening statement in commemoration of the sixtieth anniversary of the Commission. At the same meeting, statements were also made by the representatives of Finland, China, South Africa, Hungary, Jamaica, Germany and Canada.
