### **Purpose of the questionnaire**

 Designed to collect expenditure data for the SEM's framework for the years 2010 to 2018

- Directed to ministries and other general government units operating/managing programs mapped to the framework's indicators.
- Linked to the country's public budget and other agencies' financial accounts



#### Three groups of government units

Units responsible for devising social policies related to the social dimensions

Example
Ministry of Education in Jordan and
Tunisia

Units that only deliver social programs related to the social dimensions

Example Public universities in Jordan

Units that only provide transfers to other government units responsible for delivering social programs related to the social dimensions

Example
Ministry of Finance in Jordan and Tunisia



Three sets of questionnaires were designed




Questionnaire collects both budgetary and extrabudgetary expenditure





Questionnaire asks about transfers to units/individuals and tax breaks



### Disaggregation of expenditure by beneficiary and gender

- The following expenditure is disaggregated by target beneficiary groups and gender of beneficiaries
  - Operational expenditure targeted to specific beneficiary groups (excluding Investments in non-financial assets)
  - Transfers to individuals
- If the disaggregation is not available at the level of gender or beneficiary group, an indicator such as the number or percentage of beneficiary group/gender out of total will be used to estimate the disaggregation.



#### Some of the issues to be raised

 Should operational expenditure that benefit the community at large be disaggregated into the beneficiary groups targeted by the units?

(ex. Administrative and Support Program in Ministry of Education for Jordan Support and Leadership Program for Ministry of Education in Tunisia)

- Which of the 2 options is better to avoid double counting of expenditure?
  - Asking each ministry about expenditure observed in the ministry's budget and other ministries' budget (ex. Transfers from Ministry of Finance and Ministry of Planning)
  - Asking each ministry about expenditure observed in the ministry's budget only and asking Ministry of Finance about the transfers made to other ministries.
- How to take into account change in the names of programs/ministries over the years?
- Purpose of research?
