ORGANIZATION OF WORK

Note by the secretariat

- 1. The secretariat has prepared the proposed organization of work of the twenty-seventh session of the Commission in order to facilitate the consideration of the agenda items within the time limitations. - 2. The session convenes its first meeting of the senior officials segment on Monday, 7 May 2012, at 10 a.m. in the main Conference Hall at the United Nations House in Beirut. The meetings following the inaugural meeting shall start at 11.30 a.m. Two meetings will be held, one in the morning and one in the afternoon according to the annexed organization of work. The Commission will resume its work on Tuesday, 8 May 2012, at 9.30 a.m. and will hold two meetings, one in the morning and one in the afternoon. The ministerial segment of the session will start its meetings on Wednesday, 9 May 2012, and will hold one meeting in the morning and one in the afternoon, in addition to a closed meeting for the heads of delegations. The twenty-seventh session of the Commission will conclude its proceedings on Thursday, 10 May 2012, at 3 p.m.
- 3. Each presentation made by the secretariat will last 10-15 minutes and the related discussion about 30 minutes. Should the discussion of one item be completed before the specified time, the meeting will move on to the next item.
