To strengthen the means of implementation and revitalize the Global Partnership for Sustainable Development. Progress towards the attainment of the objective will help in enhancing by 2020 providing capacity-building support to developing countries, including for least developed countries to increase significantly the availability of high-quality, timely and reliable data disaggregated by income, gender, age, race, ethnicity, migratory status, disability, geographic location and other characteristics relevant in national contexts; and by 2030, build on existing initiatives to develop measurements of progress on sustainable development that complement gross domestic product, and support statistical capacity-building in developing countries

### Vision 2020

In 2020, the subprogram will shift its focus to facilitating the introduction of new technologies and data sources in official statistics, continuing closing data gaps, assisting member states in improving statistical governance and institutional issues, and to paying particular attention to official statistics in situations of war and conflict

#### This approach will include:

The use of new technologies and approaches to data collection

Intensified technical assistance to countries

Assistance to countries to undertake population census

Assistance to member states in setting strategies addressing issues of statistical governance

Organizing expert and advisory groups to provide guidance on the methodologies for social and demographic data collection.
