# PROGRESS ACHIEVED IN THE FIELD OF STATISTICS SINCE THE NINTH SESSION OF THE STATISTICAL COMMITTEE

#### STATISTICS-RELATED ACTIVITIES UNDER THE PROGRAMME OF WORK

#### **Summary**

The present report summarizes activities and their results according to the main subject-matter domains of statistics, namely: statistical policy and coordination; demographic and social statistics; and economic statistics. This format was chosen in order to enable members of the Statistical Committee to identify gaps and shortcomings, and areas for future improvement. Activities that took place over the past two years have been organized irrespective of the sources of funding or other administrative characteristics.

In addition and following up the request made by participants in the fifth meeting of the Working Group of the Statistical Committee (Beirut, 14-15 February 2012), ESCWA prepared a report on projects in progress which is available to the committee in document E/ESCWA/SD/2012/IG.1/CRP.2.

Members of the Committee are invited to express their views on the progress achieved since the ninth session of the Statistical Committee and to formulate lessons learned to guide the future work of the Committee and that of the Economic and Social Commission for Western Asia (ESCWA).

#### Introduction

- 1. The role of subprogramme 5, Statistics for evidence-based policymaking, of the programme of work for the biennium 2010-2011 is to provide a platform for the development of official statistics in the Western Asia region. The work programme is guided by the discussions of the Statistical Committee during its biennial sessions, before being submitted to the General Assembly and its subsidiary organs for consideration. Operative adjustments are made to the biennial plans as needed, and the workplan is complemented by activities covered by other sources of financing than the regular budget of the United Nations.
- 2. The work of ESCWA in 2010-2011 focused on four regional priority areas, namely managing water and energy, social policies, managing globalization and managing technology; and on three cross-cutting issues, namely, statistical capacity-building, the advancement of women and assistance to countries emerging from conflict.
- 3. In relation to the cross-cutting issues of statistics, ESCWA identified overall improvement and significant progress at the national level in data compilation and dissemination to monitor Millennium Development Goal (MDG) indicators. With support from ESCWA, six new and/or revised statistical standards or recommendations were implemented by at least seven ESCWA member countries. In addition, the System of Environmental and Economic Accounting for Water (SEEAW) has been implemented in Jordan, Egypt and Palestine. Taking into account the resource requirements and complexity of SEEAW, this should be considered an extraordinary achievement. Regarding compliance with data dissemination standards the results show important progress, exceeding expectations. With support from ESCWA, 13 of 14 ESCWA member countries are now compliant with the General Data Dissemination System (GDDS) or Special Data Dissemination Standard (SDDS) of the International Monetary Fund (IMF).
- 4. The present report summarizes the results ESCWA achieved and its activities and outputs organized according to the main subject-matter domains of statistics, irrespective of their source of funding or administrative status. This style of presentation was chosen in order to enable members of the Committee to identify gaps, shortcoming and areas for future improvement. Following up the request made by participants in the fifth meeting of the Working Group of the Statistical Committee (Beirut, 14-15 February 2012), ESCWA prepared a report on its projects currently in progress which has been made available to the Committee in document E/ESCWA/SD/2012/IG.1/CRP.2.
- 5. The Statistics Division is responsible for implementing subprogramme 5, and aims to improve the production and use of harmonized and comparable economic, social and sectoral statistics, including sex-disaggregated data, thereby allowing for informed and evidence-based decision-making.
- 6. The results achieved under each of the two expected accomplishments of this subprogramme in the biennium 2010-2011 are set out below.

**Expected accomplishment 1**: Progress in improving the national institutional framework for official statistics, particularly in conflict-affected countries and those that are less statistically developed

7. With respect to the implementation of the Fundamental Principles of Official Statistics, the results show progress overall but there are still gaps with respect to the following Principles: 1, concerning relevance, impartiality and equal access; 6, concerning confidentiality; 9, concerning international standards; and 10, concerning bilateral and multilateral cooperation in statistics. With respect to compliance with the

data dissemination standards of IMF, the results show important progress, which exceeds expectations. Thirteen out of 14 member countries are compliant with GDDS or SDDS standards of IMF.

#### Lessons learned

8. The future focus should be on implementing the Fundamental Principles of Official Statistics, particularly Principles 1, 6, 9 and 10. Implementing these Principles is not only in hands of statisticians, and it is important to involve policymakers and legislators.

**Expected accomplishment 2**: Enhanced capacity of national statistical offices to produce and disseminate relevant, timely, reliable and comparable social, economic and environment statistics and indicators, including Millennium Development Goal indicators and gender-disaggregated data, in compliance with international standards and recommendations

9. There is an overall improvement in the average availability of MDG indicators in the countries of the region of about 17 per cent since 2008, thereby indicating significant progress at the national level in data compilation and dissemination to monitor MDGs. Six new and/or revised standards or recommendations were implemented by at least seven ESCWA member countries: the 1993 System of National Accounts (SNA); the International Standard Industrial Classification of all Economic Activities (ISIC Rev. 2); the International Standard Classification of Occupations (ISCO); the Manual on Statistics of International Trade in Services (MSITS Rev. 3) or the Harmonized System (HS) according to individual country preferences; recommendations for the 2010 Round of Population and Housing Censuses; and SEEAW.

#### Lessons learned

10. More attention should be given to the quality, rather than the simple availability of MDG indicators. Countries signaled numerous discrepancies between national and international data. Arabic translations are not widely available, which harms the implementation of and compliance with new international standards.

## I. STATISTICAL POLICY AND COORDINATION

## A. OVERVIEW

- 11. The heads of national statistical offices are invited to attend the biennial sessions of the Statistical Committee. Because the biennial cycle is too infrequent, ESCWA facilitates annual meetings of the Working Group of the Statistical Committee at the request of member countries.
- 12. In addition to these meetings, ESCWA organized events and published methodological material of a cross-cutting nature, to support and monitor progress towards the goals defined in the Millennium Declaration of the United Nations and improve the quality of data and metadata. The activities of ESCWA included capacity-building and advisory services and the collection and dissemination of gender statistics.

## B. MEETINGS, EXPERT GROUPS AND WORKSHOPS

- 13. ESCWA organized two meetings for the Working Group of the Statistical Committee: the fourth meeting in Beirut, on 3 and 4 February, 2011; and the fifth meeting in Beirut, on 14 and 15 February, 2012.

## II. DEMOGRAPHIC AND SOCIAL STATISTICS

#### A. OVERVIEW

- 18. The work under subprogramme 5 has continued to enhance the capacity of national statistical offices in demographic and social statistics, focusing on methodological developments in population statistics, particularly censuses and labour statistics.
- 19. In connection with the 2010 Round of Population and Housing Censuses, ESCWA organized several activities to support census methodologies and the analysis of census results. Population and housing censuses have taken place or will soon take place in 14 member countries. Other activities were conducted to improve the collection, dissemination and analysis of labour statistics.
- 20. In addition, a group of activities focused on sex-disaggregated statistics tailored to the region or to specific member countries.

# III. ECONOMIC STATISTICS AND NATIONAL ACCOUNTS, INCLUDING ENERGY AND ENVIRONMENT STATISTICS

25. Through concerted efforts with the statistical offices of member countries, ESCWA has continued to enhance the capacity and ensure the development of the work on priority areas of economic statistics: the implementation of SNA (1993 and 2008); short-term economic statistics; International Comparison Program (ICP) and price statistics; external trade in goods and services and industrial statistics; energy and environment statistics and accounts; and information and communication technology (ICT) indicators.

#### D. TECHNICAL ADVISORY SERVICES

28. Under subprogramme 5, advisory services are provided to member countries upon request, in the following areas: national accounts; price statistics; energy and energy balance statistics; environment and sustainable development indicators; and ICT surveys. Following a high demand for technical advisory services, ESCWA recruited a regional advisor on economic statistics and national accounting. His advisory services are undertaken in conjunction with capacity-development work under the regular work programme and projects of ESCWA (such as ICP), and on the basis of requests formulated by member countries.

29. The following advisory services and technical cooperation activities and missions were organized by ESCWA:

## (a) National accounts and economic statistics

- Jordan, Department of Statistics, 4-25 September 2011, to assist staff on methods and sources used for compiling quarterly national accounts and training the staff on the Bench program which is used in compiling quarterly GDP estimates consistent with annual estimates;
- Syrian Arab Republic, Central Bureau of Statistics, 30 January-3 February 2012, to assist in balancing the supply and use table that was constructed by the national account team;
- Syrian Arab Republic, Central Bureau of Statistics, 27 February-2 March 2012, to assist in compiling the supplementary matrices to the supply and use table needed for compiling the input-output tables for the year 2009;
- Jordan, Department of Statistics, 2-25 March 2012, on rebasing the national accounts to 2006;
- Kuwait, Central Statistical Office, 7-19 April 2012, to conduct a comprehensive assessment of the
  methods and sources used for developing the new series of national accounts at constant prices
  and to develop a strategic plan for the transition to 2008 SNA;
- Qatar, Statistics Authority, 12-15 May 2012, to assist in developing real price indices and develop an initial draft of the strategy for implementing 2008 SNA;
- Oman, Ministry of National Economy, 19-30 May 2012, to conduct national workshops on national accounts;
- United Arab Emirates, National Statistics Centre, 3-7 June 2012, on compilation of supply and use tables;
- Jordan, Department of Statistics, 18 June-13 July 2012, to assess and adjust data sources and methodologies used for compiling national accounts rebased to 2006.

#### (b) Price statistics, including ICP

- United Arab Emirates, Dubai Statistical Center, 6-10 March 2011, to assist in choosing the proper methodologies and identifying the required data sources needed for compiling real-estate price indices;
- United Arab Emirates, Dubai Statistical Center, 24 April-5 May 2011, to follow up progress in the compilation of real-estate price indices and assist the Center in the compilation of the Producer Price Index (PPI):
- Egypt, Central Agency for Public Mobilisation and Statistics, 31 January-2 February 2012, to extract household consumption data from the Semper format,<sup>2</sup> to allow for the active participation of Egypt in ICP Western Asia;
- The Sudan, Central Bureau of Statistics, Cairo, 5-7 February 2012, to extract household consumption data from the Semper format, to allow for the active participation of the Sudan in ICP Western Asia;
- Kuwait, Central Statistical Office, 5-8 March 2012, for training on the validation of household consumption data and guidance on the implementation of ICP special surveys;
- Qatar, Statistics Authority, 14-16 May 2012, for training the ICP national team on ICP activities, data validation, national accounts requirements and implementation of price surveys;
- Bahrain, Central Statistics Organization, 20-21 May 2012, for training on ICP activities, data validation and the implementation of special surveys.

## (c) Energy and environment statistics

- Egypt, Central Agency for Public Mobilisation and Statistics, 27 February-1 March, 2012, to prepare a needs assessment report on energy balance, improve energy data in the energy balance tables with data from numerous surveys and administrative data from the Ministry of Petroleum. Carried out in connection with the DA project on energy statistics;
- Qatar, Statistics Authority, 4-5 March 2012, to provide technical assistance on energy statistics
  and balance in the context of the DA project on energy statistics. A needs assessment report
  prepared by an international consultant and reviewed by ESCWA was submitted to the Statistics
  Authority;
- Kuwait, Environment Public Authority, 5-8 March 2012, to provide expertise and input to the workshop between the Authority and Central Administration of Statistics on the Environmental Performance Index and environment indicators;
- United Arab Emirates, National Bureau of Statistics, 19-21 June 2012, to provide technical
  assistance on energy statistics and balance in the context of the DA project on energy statistics.
  A needs assessment report prepared by international consultant and reviewed by ESCWA was
  submitted to the National Bureau of Statistics.

## (d) ICT statistics

United Arab Emirates, National Bureau of Statistics, 27-31 March 2011, to assist on compilation of ICT indicators, organized by the Information and Communication Technology Division and Statistics Division.

## E. STUDY VISITS AND FELLOWSHIPS

30. The participation of Bahrain, the United Arab Emirates and Oman in the MEDSTAT meeting on energy balance in Paris in November 2011 was sponsored by ESCWA. ESCWA also sponsored the following: a study visit to the International Energy Agency in March 2012 for Iraqi officials working in statistics in ministries of energy and electricity; study visits for representatives of Iraq and Yemen to participate in the training course on developing and using questionnaires for agricultural statistics in Istanbul from 18 to 21 July 2011 which was organized by MEDSTAT; and participation by a Palestinian representative in the meeting of the Food and Agriculture Organization of the United Nations on agriculture statistics in Jordan.

## IV. ACTION REQUIRED OF THE STATISTICAL COMMITTEE

#### 31. The Committee is invited:

- (a) To take note of and express its views on the progress in implementing statistics-related activities under the work programme of ESCWA;
- (b) To make recommendations, on the basis of lessons learned, on future priority areas in the statistical work of ESCWA and priorities for cooperation between the national statistical offices in member countries;
- (c) To make recommendations for the continuation of ongoing statistics-oriented projects executed by ESCWA, notably the following projects (for more detail see E/ESCWA/SD/2012/IG.1/CRP.2):
  - 2011 ICP round;
  - Project on implementation of 2008 SNA;
  - DA project on energy statistics and energy balance;
  - DA project on achieving gender equality and women's empowerment;
  - DA project on monitoring MDGs;
  - Strengthening national capacities in social statistics and preparedness for the upcoming International Conference on Population and Development Beyond 2014;
  - Analysis of gender equality gaps in the Arab region;
  - DA project on NTA;
  - Labour statistics and cooperation with relevant organizations.
