Introduction

- 1. The objective of the Economic and Social Commission for Western Asia (ESCWA) subprogramme 5, "Statistics for evidence-based policymaking", for the biennium 2012-2013, is to improve the production, harmonization and dissemination of quality demographic, social, economic and environmental indicators, including indicators on societal development and progress towards development goals, gender-disaggregated data and gender-sensitive indicators, in order to facilitate evidence-based policymaking by national and international decision makers and civil society. The responsibility for implementing subprogramme 5 is vested within the Statistics Division and the Statistical Committee plays a steering role in that implementation.
- 2. This document presents the activities planned in the field of statistics for the remainder of the biennium 2012-2013. The programme of work in the field of statistics for that biennium was approved by the Statistical Committee at its ninth session (Beirut, 13-15 October 2010) and, as part of the ESCWA programme of work, at the twenty-seventh session of ESCWA (Beirut, 7-10 May 2012). Some adjustment of priorities and focus may be needed to reflect the present needs of official statistics and address the current developments in the Arab region. Therefore, the Committee is invited to review the planned statistical activities and outputs and to provide guidance to the secretariat in that regard.

I. STRATEGIC AND MANAGERIAL ISSUES OF OFFICIAL STATISTICS

- 3. Strategic objectives: promoting progress in institutional building of official statistics in the Western Asia region, in line with the Fundamental Principles of Official Statistics and national strategies for the development of statistics; and providing official statistics for the region and its countries, based on scientific knowledge and on the respect of principles of independence of statisticians. Subprogramme 5 should provide a forum for exchange of knowledge, experience, good practice and ideas between national statistical offices in the region.
- 4. Goals for 2013: to conduct consultations prior to the forty-fourth session of the United Nations Statistical Commission (New York, 26 February 1 March 2013), with greater involvement of subject matter experts from national statistical offices; to develop a capacity-building programme on quality of official statistics; and to strengthen the role of the Statistical Committee and national statistical offices in coordinating official statistics. In particular, the Statistics Division at ESCWA and the Palestinian Central Bureau of Statistics will take part in the work of the Friends of the Chair Group on Statistical Coordination within the United Nations system.

- 5. Strategic objectives: improving population and vital statistics produced by national statistical offices; enhancing reliability of national data and estimates, and encouraging the use of administrative registers and records for that purpose, with a view to ensuring close involvement of national statistical offices in the production of population estimates; developing gender statistics to meet the needs of policymakers; increasing the capacity of national statistical offices in producing statistics on household income, expenditure and poverty; and promoting regular production of statistics on labour force and quality of employment.
- 6. Goals for 2013: to continue activities towards improved population statistics, population censuses and gender statistics, in cooperation with United Nations Population Fund (UNFPA), UN-Women and the United Nations Statistics Division; and to pursue programmes of capacity-building on population, labour and gender statistics.

III. ECONOMIC STATISTICS

- 7. Strategic objectives: promoting full implementation of the System of National Accounts (SNA) by ESCWA member countries and, ultimately, the migration to the 2008 SNA; increasing comparability of price statistics across member countries and producing purchasing power parity indices for homogenous scalability in the measurement of development indicators; establishing a quarterly time series record of inflation rates behaviour in various countries and sectors, and promoting the harmonization and improvement of consumer price index (CPI) production through regional integration; improving collection and harmonization of concepts for informal sector statistics; enhancing consistency and harmonization of trade statistics data and improving quality of data in such global databases as the United Nations Comtrade; revitalising activities in the field of industrial statistics; and assisting member countries in the collection of data and the production of industrial statistics.
- 8. Goals for 2013: to compile and validate price data for the International Comparison Program (ICP) in the Western Asia region, and compute the preliminary results of purchasing power parities and major findings; to collect price data for ICP in the Western Asia region; to implement SNA; and to track quarterly sectoral price inflationary movement and promote the proposal for CPI-ICP integration.

IV. ENVIRONMENT AND ENERGY STATISTICS

9. Strategic objectives: devising a framework for environmental-economic accounting for countries in the ESCWA region, with a view to improving harmonization of data on the region in regional and global databases; maintaining activities in statistics on water resources and sharing achievements and results of ESCWA countries with others, considering that the ESCWA region is a leader with respect to water resources; harmonizing concepts and measurements for energy statistics and increasing quality and coverage

of disseminated data on energy; and advancing the implementation of sustainable development indicators in the Arab countries.

10. Goals for 2013: to engage in dialogues with regional and international partners, including the International Energy Agency, MEDSTAT III and the European Environment Agency, on a joint approach to activities in environment and energy statistics; and to make progress on the United Nations Development Account project on energy statistics and energy balances.

- 11. *Strategic objectives*: making monitoring of progress an integral component of official statistics in the region; keeping abreast of new developments in measuring societal progress; and using the framework of the Global Project on Measuring the Progress of Societies by the Organisation for Economic Co-operation and Development in the analysis, localization and implementation of indicators to measure societal progress.
- 12. Goals for 2013: to work with other regional and international organizations participating in the Task Force on Statistical Coordination for Arab States on establishing a database on the Millennium Development Goals (MDGs) comprising international and national data, and using that database to reconcile discrepancies and variations in data; and to carry out activities aimed at reconciling variation and discrepancies in MDG related data.
